## Good number of foreign militants present in Kashmir: J&K DGP

rector General of Police (DGP) Dilbag Singh on Monday said a "good number" of foreign militants are present in the valley, but they are "lying low" and "keeping a distance". Addressing a press conference at the Polie Control Room (PCR) here, he said only two foreign militants have been killed in Kashmir this year in two encounters. "Both were killed in Sopore (in north Kashmir's Baramulla district), including one today. Both were from the Lashkar-e-Toiba (LeT), which clearly indicates that foreign terrorists are present here. They are lying low and keeping a distance. We have their details, according to which our operations are launched," the DGP said.

The understanding at a high level on the ceasefire pact between the Indian and Pakistani armies has had a positive impact and we welcome that.
