Nagaland principal secy briefing on COVID-19

KOHIMA, OCT 29 /--/ A total of ~98 COVID-19 positive cases have been detected today - 13 in Kohima, 71 in Dimapur, 1 in Kiphire, 3 in Mokokchung, 5 in Mon, 3 in Tuensang, 1 in Wokha and 1 in Zunheboto. The total number of positive cases in the State now stands at 8,824. Out of the 8,824 positive cases, the total recoveries so far are 6,869. The active cases are 1,840 and there have been 28 deaths. As per the severity of symptoms 1,747 active cases are asymptomatic, 73 active cases are mild, 12 active cases are moderate on oxygen, 1 active case is severe on oxygen, 3 active cases are critical with oxygen and 4 active cases are on a ventilator. Further, out of 8,824 positive cases, the distribution across various categories of people is 3,843 cases of Armed Forces/Police, 1,642 cases of Returnees, 2,906 cases of Traced Contacts, and 433 cases of frontline workers. A total of 60,952 samples have been sent for testing through RT-PCR and the results of 59,854 samples have been received. In addition, a total of 33,161 samples have been sent for testing on Truenat, and results of 33,088 samples have been received. Through Rapid Antigen Test 3,772 samples have been tested. (DIPR)

ruary; when two piglets for AI in pigs project was procured from Lungpuzawl Vety Farm; and these two piglets Landrace leh Yorkshire were reared at Vety

Complex, Siaha to its full maturity, and their sperm extracted from this July 2020 onward. Soon after, *AI in pigs project* was carried out on two sows be-

longing to FC Zase, College Vaih, and C Rohlira, New Siaha, respectively on July 4, 2020. These two sows successfully delivered their offsprings last night at around 9:00 pm. Sow belonging to FC Zase delivered 8 piglets and C Rohlira's delivered 6 piglets. The semen of one Boar is sufficed to inseminate about 200 to 250 sows and there are 131 artificially inseminated sows in the Siaha district as of now. If all these 131 sows successfully delivered their offsprings too, then Siaha district will soon become self-sufficient in Pork. (DIPR)

AIZAWL, OCT 29 /--/ As numbers of COVID-19 positive cases have been detected from the community in Lawngtlai Vengpui and Vengpui-II Village Council areas. New seven covid cases were detected from these areas. After deliberate risk assessment by medical teams and on the recommendation of the Chief Medical Officer, Lawngtlai district, the Deputy Commissioner Lawngtlai Dr Andrew H. Vanlaldika today declared two village council areas within Lawngtlai town, namely - Vengpui and Vengpui-II as containment zones as per The Mizoram Epidemic Diseases (COVID-19) Regulations, 2020 to

prevent further spread of the virus. Movement in and out the containment areas is prohibited except for those given permission by the Deputy Commissioner or by the concerned VLTs, law enforcement agencies, medical, sanitation, PHE and P&E personnel on duty, COVID-19 executive

duty, media personnel and milkmen. However, the main roads passing through these areas will remain open. The order is to be effective from today until further orders. Following this order, active case search will be conducted by medical

teams within these areas. Travel history, contact history, suspected COVID-19 symptoms, etc will be taken into account and those falling within the risk/suspected group will be tested for COVID-19. (DIPR)
