PANAJI, OCT 26 /--/ Ahead of the Goa Assembly elections due early next year, senior Congress leader Rahul Gandhi will arrive in the coastal state for a daylong visit on October 30, state party chief Girish Chodankar said on Tuesday.

During the visit, Gandhi would address a convention of Congress workers at SPM Stadium in Bambolim near here and also participate in various other party-level events scheduled that day, Chodankar told news agency PTI. According to a senior party functionary, Gandhi will arrive at 11 am October 30 following which he will travel to the International Centre at Dona Paula where he would hold a meeting with party officials. Rahul's visit assumes significance as the Congress is gearing up for the state Assembly polls next year.

In the 2017 Goa Assembly polls, the Congress had won the highest 17 seats in the 40member House, restricting the main opponent BJP to 13. But, the saffron party moved to ally with regional parties and came to power under leadership Manohar Parrikar, now deceased. The Congress had accused the BJP of "stealing" the mandate, a charge the saffron party rejected. Over the years, the Congress's strength in the state Assembly dwindled to four after many of its MLAs switched sides and joined the ruling BJP.

# India, UK conduct military drills in Arabian Sea

NEW DELHI, OCT 26 /--/ India and the UK are carrying out a series of complex military drills as part of a tri-services wargame in the Arabian Sea, billed as the most ambitious exercise by the two coun-

The UK's Carrier Strike Group (CSG) led by its largest warship HMS Queen Elizabeth and several other frontline ships of the two navies are participating in the week-long 'Konkan Shakti' exercise that began on October 21, officials said. A carrier battle group or carrier strike group is a mega naval fleet comprising an aircraft carrier, accompanied by a large number of destroyers, frigates and other ships. The UK is only the third country after the US and Russia with which India is conducting a tri-services exercise. Indian Navy's MiG 29K jets, the Royal Navy's F-35B aircraft and Indian Air Force's SU-30 and Jaguar fighters were among the key assets deployed for the exercise, the officials

Indian Navy spokesperson Commander Vivek Madhwal said the sea phase of the maiden tri-service exercise commenced off the Konkan coast in the Arabian Sea on Sunday after the completion of an exhaustive harbour phase. The British High Commission said personnel of all three services from both countries were participating in the tri-service exercise and described it as the "most ambitious conducted by the two countries to date". It said the exercise is another step in deepening bilateral defence and security ties and boosting strategic cooperation in the Indo-Pacific region. (PTI)

SRINAGAR, OCT 26 /--/ The Jammu and Kashmir Police has registered two cases against medical students here under the Unlawful Activities (Prevention) Act (UAPA) for celebrating Pakistan's victory over India in a T20 international cricket match, officials said on Tuesday.

The cases have been

registered against the students living in hostels at the Government Medical College in Karan Nagar here and SKIMS Soura, the officials said. The two cases under the UAPA have been registered in Karan Nagar and Soura police stations respectively, they said. Videos of the celebrations of Pakistan's victory against arch-rivals India at many places in the valley went viral on social media. The match took place on Sunday in Dubai. At many places, fire crackers were also burst following Pakistan's victory. The J&K Students Association has. meanwhile, urged Lieutenant Governor Manoj Sinha to withdraw the UAPA charges on humanitarian

In a statement, national

spokesperson of the Association, Nasir Khuehami, said the UAPA charges against students is a harsh punishment which will ruin their future and will further alienate them . We are not justifying their act, but it will result in their career assassination. The charges will have serious consequences on academic and future career of the students, Khuehami said. PDP president Mehbooba Mufti accused the Centre of resorting to "vindictive" action against Kashmiri youth and said such steps will "alienate them further." Mufti said the Centre should instead have tried to ascertain why the educated youth choose to identify with Pakistan.

"HMs (Union Home Minister Amit Shah) 'Mann ki baat' with Kashmiri youth started with slapping UAPA against medical students for celebrating Pakistan's win. Instead of trying to ascertain why educated youth choose to identify with Pakistan, GOI resorting to vindictive actions. Such steps will alienate them further," the former Jammu and Kashmir chief

minister said on Twitter. Shah was on a four-day visit to Jammu and Kash-

Jammu and Kashmir BJP chief Ravinder Raina accused the PDP president of having "Talibani ideology" and said anyone who celebrated Pakistan's recent win over India in a T20 World Cup match would be iailed for "conspiring" against the country.
